1. The Name of the Trust is "Rao Chandgi Ram (Yadav) Welfare Trust."
2. The Registered office of the Trust is situated at SIRSA(Distt. SIRSA) in the State of Haryana.
3. The objects for which the Trust is established are :-
  - (1) To open primary, middle, High, senior secondary schools in rural and Urban Areas.
  - (2) To make other provisions for imparting education in Arts, Science, Medical and Technology and to take necessary steps to open Hospital, Laboratories etc. for opening a Medical College.
  - (3) To hold and manage educational endowments to erect, equip and maintain colleges, libraries, laboratories, hostels, schools and to make regulations relating to the residence and conduct of students studying and residing in the Institutions maintained and managed by the Trust.
  - (4) To do all such acts as tend to promote studies, research, games and sports and to make temples for imparting moral education.
  - (5) To open schools and colleges for boys and girls.
  - (6) To provide means of giving technical, Industrial, Medical, Commercial and vocational education.
  - (7) To watch over, support, protect, extend and defend the rights of the following members of Trust,
- 8) To encourage the growth of friendly feelings and fraternity amongst the society.
- 9) To settle disputes amongst the members of the Trust.
- 10) To obtain, sanction, privileges, advantages, reliefs, cooperation from any authority in the interest of the Trust.
- 11) To accept any bequest, gift or donations whatsoever (whether of money or of property of any description) and to apply the same or the proceeds of sale for the purposes, and aim of the Trust.

- (12) To collect money through lawful means for the objects of the Trust and to apply or deal with the same in such manner which is most beneficial for giving effect to the objects of the Trust.
  - (13) To acquire by gift, donation, purchase, take on lease or otherwise and all other properties, movable and immovable, which the Trust for the purpose thereof, may from time to time, think proper.
  - (14) To sell, improve, manage, develop, exchange, lease or let out and subject mortgage, dispose off or otherwise deal with all or any part of the property of the Trust.
  - (15) To construct upon any premises acquired for the purpose of the Trust any buildings for the service and welfare of the society and to let, and to remove any building upon such premises.
  - (16) To borrow or raise any moneys, required for the purpose of the Trust upon such terms and in such a manner and on such securities as may be determined from time to time and in particular by a Mortgage, Charge, or Lien on the Trust's property.
  - (17) To draw, make, accept, endorse and execute promissory notes, bills of exchange, cheques and other negotiable instruments.
  - (18) To do all such other things as are incidental and conducive to the attainment of the above objects or any of them.
  - (19) The Trust by its constitution is required to apply the profits, if any, or other income in promoting its objects.
  - (20) The property of the Trust is now Rs. 4000/- (four thousands only) which has been donated by members of the Trust.

## RULES AND REGULATIONS.

RAO CHANDRA RAM (YADAV) PUBLIC WEL.PARKS TRUST, SINGH (HARYANA)

Any person wishing to become a member of the Trust (and is of 21 years or more), he shall have to apply to the President of the Trust. His application will be well scrutinised by the Managing Committee. The President can reject or select the member with the consent of the other members.

Every Trustee shall donate at least Rs. 40,000/- (forty thousand rupees) in cash or property worth the same amount within a period of three years; otherwise his membership will come to an end.

The Trust shall consist of five members including the office  
men and the patrons will not be included in this number.

The agenda of the Managing Committee's meeting will be three  
days.

Any person may be granted honorary membership of the Trust for devoted services to the Trust or exceptional and outstanding help given by him. Such a member will be for a period of two years only. The following circumstances shall cause a vacancy in the Trust: death of member.

These to be a member of the Trust.

\*Dies for insolvency or is declared insolvent.

any casual vacancy occurring in the Trust shall be filled by the  
gent in consultation with the other members.

The Trust shall frame its own rules of business and may from time to time amend, alter or cancel them, if necessary.

Any member of the Trust, who does not abide by the rules and regulations or creates indiscipline of any kind can be removed from the membership of the Trust by the President with the approval of the majority of other members.

President will hold office for three years and may change the members office-bearers of the Managing Committee from time to time when he has to do so with the consent of the Managing Committee. In case, the vacancy of President falls vacant, the Vice-President shall be the President for the unexpired period.

1. The retiring President is eligible for re-election.

The Quorum for holding the annual General meeting of the Trust will be one-third of the total strength. Fraction is to be ignored.

The ordinary annual general meeting of the Trust shall be held every year in the month of December.

2. The meeting of the Managing Committee shall be called by the President or by the Secretary of the Managing Committee.

3. The Managing Committee may from time to time appoint sub-committees for special purposes.

4. The President on the request made by 1/2 members of the Managing Committee will call an extra-ordinary general meeting of the Trust giving at least five days notice.

5. All the decisions of the Managing Committee or of the members of the Trust shall be by the majority of votes. In case of a tie, the President shall exercise his casting vote, not otherwise.

6. Three days notice is required to call an emergency meeting of the Managing Committee and whereas seven days notice is required to call a annual ordinary general meeting of the Trust.

- (a) The functions and duties of the President shall be:
- (a) To accord sanction to any new venture or construction.
- (b) To preside over the meeting and gatherings of the committee as well as of the Trust, to take votes to declare the result of voting and to determine the order, in which the several proposals should be laid before the Committee.

  - The funds of the Trust shall be deposited in the Bank.
  - The Secretary of the Trust will also act as Manager of the schools colleges and sports clubs run by the Trust.
  - The functions and duties of Vice-President in the absence of President, Vice President shall perform the duties of the President.


